Regarding our balance sheet — Our total available balance in all funds at March 31, 2022 was \$3,163.39. Our ending unallocated balance in our General Fund was \$24.17 and prudent reserve was \$2,300.26.

Regarding our March and YTD profit and loss — Our total income for March was \$5,911.28, which was \$3,461.28 (or 141.3%) MORE than our March income plan of \$2,450. March income was made up of \$410 in BDA group contributions; \$3,000 in contributions to public information; \$674.78 in distributions from BDA Workshops; and \$1,836.50 in registration contributions related to the various events we are hosting.

Our YTD income from unearmarked group and member contributions is \$880 (or 8%); YTD income from earmarked funds for literature and public information is \$6,000 (or 55%); and YTD income from events, including distributions from the BDA Solvency Immersion Conference, is \$4,039.59 (or 37%).

Total YTD member contributions, both general and earmarked, are \$6,480.00.

Total YTD BDA Help for Debtors event income is \$2,999.50.

For a combined total income of \$10,919.59 for the months of January through March.

Our expenses for March included: \$297 for 27 new eBook requests, at \$11 each including sales tax paid in WA state; \$800 to our literature coordinator for shipping supplies and costs, including a significant increase in international requests and shipments; \$41.52 in paypal fees on event registrations; \$300 addition to our prudent reserve per our plan; \$0.03 in interest earned; and a \$4,400 progress payment to our media special workers for our new PSA distribution.

Regarding our YTD spending plan comparison for the month of March — We were \$1,069.59 (or 10.9%) OVER our income plan and \$358.70 (or 2.8%) OVER our expense plan, which was spent on the high costs of shipping literature internationally, which we are very happy to do. We are ending at \$710.89 (or 23.7%) AHEAD OF our plan for income over expenses for the first three months of 2022.

We were OVER by \$1,230 in literature expenses for January through March, due to generous gifting of literature to our fellow debtors and maintenance of a healthy inventory for future months. Our ending literature fund balance at March 31st was \$134.94. As of March, we were <\$471.30> UNDER plan in our overhead expenses, even though we distributed to the GSB and added to our prudent reserve per our plan. We were <\$400> under plan in public information with our media special workers paid within agreed upon terms. Our next fourth and final payment on the first 2022 PSA distribution will be \$3,100 at the end of either April or May, for a total of \$12,700, including production of our new PSA at the end of 2021 and the addition of pitch services to radio stations in four selected US cities. Prayers said to reach the greatest number of still-suffering debtors possible.
